The consultation can be done either online or in person.

MARTYN'S LAW - BUSINESS SUPPORT

Last week, Martyn's Law was discussed with experts Danni Grant and Nick Aldworth from CT Protect. Nick, a leading UK security figure, highlighted its significance post the 2017 Manchester Arena bombing.

Compliance Readiness: BIDs should prepare for Martyn's Law within 18-24 months, focusing on tackling terrorist threats in public spaces.

Requirements: Premises with 100+ capacity must have lockdown, invacuation, evacuation, and communication plans in place.

Regulatory Oversight: A regulator will ensure compliance, with potential penalties for non-compliance.

Training Assistance: CT Protect offers brief training on threat understanding, vulnerability assessment, response planning, and activation.


